

**ORDINANCE AMENDING THE CODE OF MATTESON, COOK COUNTY, ILLINOIS**

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Matteson, Cook County, Illinois, that the Title III of the Code of Matteson is hereby amended by adding the following new chapter:

**CHAPTER 41: FINES**

*§41:01. Imposition of Fines.* In lieu of attendance at an adjudicatory hearing, the following fines are hereby imposed for violations of this village code and may be paid to the Village in lieu of appearing before a hearing officer of the Ordinance Enforcement Department as established pursuant to Chapter 38 but only where payment is made no less than forty-eight (48) hours prior to the date and time assigned for said adjudicatory hearing:




This Ordinance shall be in full force and effect immediately upon its passage by the President and Board of Trustees and approval as provided by law.
