He reported that any of the elected officials are welcomed to attend and that he will be inviting various department heads in the coming weeks. He stated that future meetings will be held at various locations in the Village. He reported that the second Board Meeting in January has been canceled and the next Board Meeting will be held on February 2, 2009. He reported that a workshop regarding the Frankfort Park District Petitions will be held for Glen Eagle subdivision residents on January 12, 2009 at 7:30 p.m. at the Village Hall. 9. OPPORTUNITY FOR PUBLIC COMMENT

Ms. Peggy Walton of 6333 Michael Lane stated that ice and snow are not being removed from her street. She suggested that salt, in lieu of its increased cost in the Winter, be purchased in the Summer. She also reported that she has difficulty reaching staff when she calls the Village. She suggested that residents be allowed to volunteer to answer phones.

President Ashmore stated that the customer service issue will be looked into and he asked Jerry Bland to speak on the snow removal issue.

Mr. Bland reported that additional salt has been purchased and that a chemical has been purchased to mix with the salt to assist it in breaking down the ice. He reported that the snow removal and response issues are being looked into to and that residents should notice improvements soon.

Trustee Sawyer III invited elected officials to walk through the Public Works facility. He stated that the facility is too small, very old and a new facility is desperately needed.

President Ashmore stated that the entire Public Works Department is being looked at. He stated that in addition to better snow response time, some of the issues being discussed are: the possibility of increasing the number of staff and the possibility of their being two salt domes in the Village. He

stated that those issues depend on the budget, that he appreciates the work Public Works is doing and that residents will see an improvement soon.

Trustee Imoukhuede stated that we shall do our best to improve and that he applauds the Public Works Department.

Trustee Imoukhuede made a Motion to adjourn to Executive Session under the Open Meetings Act, Personnel – Section 2(c)(1) – Employee hiring, firing, compensation, discipline and performance and under the Open Meetings Act, Litigation – Section 2(c)(11) – Pending, probable or imminent litigation with no need to reconvene. Seconded by Trustee Sawyer III.
