SPECIAL REPORT
1. ICSC Convention

- Developers are still interested in Matteson
- Some comments from the developers included that the median income, the location and demographics of the Village and the Village's plan for the future are all impressive.
- Developers they met included: Dunkin Donuts, Outlet Malls, a performing arts theater, developer/owners currently in the Village.
- Some Economic Development goals include: developing the corner of Lincoln Highway and Cicero, creating a "central hub" which will centrally locate public use facilities such as the Library and a Theater, making them easily accessible, business retention.
- The Village will play a proactive role in the Lincoln Mall development

Trustee Burton stated that the Village as a whole needs to take the following steps toward Economic Improvements:

- Everyone must shop in Matteson as developers say that spending dollar statistics matter to them.
- Promote Matteson. The Village can assist by creating a form letter to retailers on the website of products the residents would like to see in the stores.
- Realize how good a town we have as almost every developer at the convention is already here in the Village.
