Vehicle Stickers, valid for the year, **April 1, 2018 through March 31, 2019**, will be on sale beginning February 5, 2018. Any vehicle stickers purchased on April 3rd and after, please refer to the fee schedule below. The sticker must be exhibited on the vehicle windshield by April 2, 2018 to avoid a citation.

Either the old sticker (showing number and expiration date) or receipt showing proof of purchase of old sticker would need to be brought in to take advantage of a \$6.50

## **VEHICLE STICKER APPLICATION FORM INSTRUCTIONS**

### **PLEASE READ AND FOLLOW THESE DIRECTIONS CAREFULLY:**

1. The Vehicle Sticker Application Form is in Adobe Fill-In Format. Click in the space where you want to add your information, and start typing. Once completed, print out form. A vehicle sticker may be obtained using this form via the **MAIL** or at the **VILLAGE HALL**.
2. The required fee is listed on the Fee Schedule. **The application will be returned if the required information is not furnished, and/or the amount is insufficient.**
3. Mail **BOTH COPIES** of form along with a check or money order, made payable to the **VILLAGE OF MATTESON** for the required amount, or apply in person at the Village Hall, 4900 Village Commons.
4. A customer receipt will be returned to you with your Vehicle Sticker. If you have any questions, please call the Village Hall at (708) 283-4900.
5. **SENIOR CITIZEN RATES ARE AVAILABLE FOR RESIDENTS WHO ARE 65 OR OLDER. ONLY ONE SENIOR CITIZEN RATE PER HOUSEHOLD IS ALLOWED.**
6. Reduced rate available for passenger cars licensed to driver and owner receiving Social Security Disability Income. Must provide benefit verification letter. Sticker cannot be purchased at the discounted rate without letter. One reduced rate sticker per household.
7. **NEW OR ADDITIONAL VEHICLE:** If a new or additional vehicle is purchased, application for vehicle sticker must be made at the Village Hall within 30 days after purchase in order to receive the lowest possible rate. There are substantial rate increases if vehicle sticker is not purchased before the deadline.
8. **TRANSFERS:** A vehicle sticker may be transferred to a replacement vehicle by bringing into the Village Hall the portion of the old sticker that shows the sticker number or the receipt showing the purchase of a current vehicle sticker. Transfers must be purchased within 30 days of obtaining the replacement vehicle to receive the lowest possible rate. There are substantial rate increases if the vehicle sticker is not transferred before the deadline.
9. Not responsible if lost in the mail.
10. Failure to receive an application will not relieve you of penalties accruing if vehicle sticker is not purchased before penalty date.
